Reflecting on Urayasu's Nori (Seaweed) Cultivation



Urayasu was once a leading producer of nori in Tokyo Bay and was well-known as a "nori town." According to records from 1938, Urayasu ranked first in Chiba Prefecture for both the volume and value of nori harvested, making it one of the top nori production areas in the country. The nori harvest took place from around November to March. The sight of Beka-bune boats fully loaded with nori lining the riverbanks and the expansive nori drying grounds was a quintessential winter scene in Urayasu.

Winter Special Exhibition: "Nori Cultivation in Urayasu"



zation. As a topical exhibit, we introduce the evolution of nori production through mechanization.

Urayasu completely relinquished its fishing rights in 1971. However, nori cultivation alone continued until 1975 by applying for short-term licenses. From the late 1950s onward, while the marine environment deteriorated, nori production actually increased due to mechanization.

Nori from Chiba Prefecture

Although nori cultivation in Urayasu came to an end, it still continues in Chiba Prefecture today in Ichikawa, Funabashi, Kisarazu, and Futsu cities. Chiba-produced nori is said to have "excellent color, taste, and aroma," and although production volume is

not large, it is known as a high-quality luxury product. The special exhibition introduces nori shops in the city that carry Chiba nori and the rare "Aomaze Nori," which contains green seaweed (Aonori).

Does Nori "Sing"!?

From January to February, the Folk Museum offers a "Nori-suki (nori-making) experience" for 4th-grade elementary school students. Inside the museum, you can see nori made during these sessions being dried. When the drying nori loses its moisture, it makes a "crackling" sound, which nori fishermen used to call "the singing of the nori." Please stop by and try to hear the sound of the nori "sing." *Nori drying will be conducted until around Sunday, February 22 (Please note it may not be on display at all times).

*To receive a consultation, an advance reservation is required via the National Tax Agency official LINE account (@kokuzei). Reservations are accepted from 2 weeks to 2 days before the desired consultation date. From Monday, February 16, numbered entry tickets for same-day reception will be distributed from 8:30 a.m., but reception may close early depending on the situation.

..... How to File

Electronic Filing

On the National Tax Agency website "Preparation Corner for Final Tax Returns" (<https://www.keisan.nta.go.jp>), you can create income tax returns by simply entering amounts following the on-screen instructions. By reading your My Number Card, you can submit the return via e-Tax. Additionally, by linking with Myaportal, information regarding income and deductions can be automatically entered into the return.

Submission of Tax Returns

Civic Hall (Shimin Hall) (City Hall 1F): From Monday, February 16 to Monday, March 16, 9:00 a.m. - 4:00 p.m. (Excluding Saturday and Monday, February 23 (Public Holiday)), a dropbox will be installed for prepared tax returns.

..... Who Needs to File

Among those registered as residents of Urayasu City as of January 1, 2026, those who fall under any of the following:

- Those who had no income from January to December 2025 and are not a dependent of anyone, or are a dependent of someone in a different household. *Filing is required even if you are a dependent of someone working away from home.
- Those receiving public pensions based on overseas laws, or those receiving only tax-exempt income such as survivors' pension, disability pension, or unemployment benefits.
- Those whose employer did not submit a Wage Payment Report to Urayasu City.

The following people do not need to file:

- Those who file a final income tax return for 2025.
- Those whose only income is from public pensions or wages and have no additional deductions.

Urayasu City Price Hike Relief Gift Certificates

To support citizens' lives and revitalize the local economy, "Urayasu City Price Hike Relief Gift Certificates" will be distributed, which can be used at participating shops and businesses within the city. The certificates will be mailed sequentially to heads of households starting around mid-February.

Target: Those registered as residents of Urayasu City as of January 1. **Face Value:** 5,000 yen per person (Five 1,000 yen certificates).

Participating Stores: To be announced around Mid-February on the Urayasu City Price Hike Relief Gift Certificate special website (<https://urayasu-shohinken.jp>), etc. Alternatively, please see the list of participating stores enclosed with the certificates.

Validity Period: Sunday, March 1 - Monday, August 31

FY2025 Child-rearing Support Allowance for Rising Prices

To support child-rearing households affected by rising prices, 20,000 yen per eligible child will be provided.

Eligibility:

1. Those who received the Child Allowance (Jido Teate) from Urayasu City for September 2025.
2. Public servants who received the Child Allowance for September 2025 from their affiliated office.
3. Parents/guardians raising children born between October 1, 2025, and April 1, 2026.
4. Those who became new recipients of the Child Allowance due to divorce, etc. (from October 2025 onward).

Application:

For those under category 1: No application is required. In principle, the allowance will be transferred to the

same account as the Child Allowance.

For those under categories 2-4: Please submit an application form by Tuesday, March 31 (must arrive by the deadline). Forms are available at the Child Services Section (Kodomo-ka) (City Hall 2F) or can be downloaded from the city website. Submit directly or by mail to: Urayasu City Hall, Child Services Section (Kodomo-ka), 279-8501. Alternatively, apply via the city website.

Note: If you wish to change your bank account, please check the city website. Please bring something that shows the applicant's transfer account information (bankbook or cash card). This is not necessary if you wish to use the public money receipt account registered on Myaportal.

A Place that Preserves the Memory of a Fishing Town


When people outside the city are asked what comes to mind when they think of Urayasu, many mention its history as a coastal fishing town, in addition to being a theme park and residential city. At the Folk Museum (Kyodo Hakubutsukan), in addition to exhibits of historical materials, the era of living with the sea is recreated in the outdoor exhibition area. You can play traditional games while walking on Urayasu's unique seashell paths, and even ride an actual Beka-bune boat.

With the complete relinquishment of fishing rights in 1971, Urayasu's fishing industry came to an end (with some exceptions). However, in the Motomachi area, the Former Udagawa Family Residence and Former Otsuka Family Residence are preserved, allowing visitors to feel the remnants of a fishing

town. Additionally, there are places in the Nakamachi and Shinmachi areas that remind us that these areas were a rich sea before the public water reclamation project.

The "Fishery Memorial Monument" in Wakashio Park in Mihami, erected in 1976, features a monument shaped like a Beka-bune boat, conveying those days to the present. In Takasu, there is the Fishery Memorial Park (Gyogyo Kinen Koen). Among the many markers indicating fishing grounds and boundaries, this is the site where the "Ryuuguu-Bongi" (a post for Sujinsai festivals praying for a large catch) once stood. It is a very important place for Urayasu's fishing history. Today, reliefs and monuments are installed there to pass on the history of those times.
