State of Emergency Declared!!

We ask for your continued cooperation in avoiding nonessential outings, washing hands and making sure to wear a mask.

Overview on the State of Emergency

- ► Eating establishments are to shorten their business hours by closing at 8 p.m. and alcoholic beverages are served between 11 a.m. and 7 p.m.
- ► Encourage remote work to reduce commuter traffic by 70%
- ► Ensure to avoid nonessential outings after 8 p.m.
- ► Limit spectators at events to whichever is lesser in numbers, either 5,000 people or 50% of full capacity.

Our Response

While we will continue to support our medical institutions, we have reexamined the service hours of public facilities and dates for scheduled events. We will not be closing elementary and middle schools, child development clubs, or other childcare facilities.

◆ The Urayasu City coming-of-age ceremony scheduled for January 11 (Mon., national holiday) has been postponed to March 7 (Sun.)

Announcement Regarding the Kakutei Shinkoku (Income Tax Return)

The contents may be updated due to the impact of the novel coronavirus.

Kakutei Shinkoku (income tax return) is a filing process to report the amount of income tax (national tax.) Usually the tax office provides consultations or accepts submissions, but at Urayasu City, tax return consultation service and a box to submit your completed tax return is provided at Culture Hall, with the cooperation of the Ichikawa Tax Accountant's Association commissioned by Ichikawa Tax Office. Also, tax return forms will be distributed at public facilities, although types are limited.

Changes made for this Year

- ◆ To prevent the spread of the novel coronavirus infection, consultation services that were annually provided from mid-February to mid-March will be canceled.
- ◆ To promote the submission of tax returns online, Ichikawa Tax Office will host ID/ Password Registration Venue that will help you file your tax return from your personal computer or smartphone.
- ◆ We will not be accepting the file in person, and submission should be made by post.

Eligibility:

 Those with employment income (those receiving an income from two or more locations, those who have not completed the year-end tax adjustments, etc.)

Note: Limited to those with an employment income of \(\frac{4}{2}\)0 million or less.

- Those receiving an income from pensions
- Those receiving an individual pension from a life insurance policy or the post office
- Those receiving a full-term insurance benefit or a cancellation refund
- Among those with a business income, a real estate income, or a miscellaneous income (excluding a

miscellaneous income related to financial assets such as virtual currencies), whose income (before applying the full-time employee exemption or full-time employee income and/or special exemption for blue return taxpayers) for FY2019 amounted to ¥3 million or less (consumption tax also accepted).

Note: Limited to those who receive an annual salary of ¥20 million or less. Submission of completed tax return by itself will not be accepted during this period

What to bring: Your tax withholding slip, your personal seal (an unregistered seal is acceptable), various tax exemption certificates and your statement of medical expenses deduction, documentation that indicates your financial account numbers, a calculator, writing instruments, your My Number Card (or documentation to confirm your individual number and your personal identification), and a copy of your income tax report from the previous year (used as a reference for consultation)

Note: To receive medical expense deductions, attachments and submissions of receipts are no longer required. Instead, you are required to submit a "Statement of Medical Expenses Deduction." File Your Tax Return by Computer or Smart-

What to prepare before filing tax returns by e-Tax

► When using My Number Card

If you are using My Number Card to file your tax return, you will need an IC card reader/writer or a smartphone compatible with My Number Card.

▶When using ID and Password

You can register your ID and password to file your tax return using e-Tax. If you wish to register, please visit the following venue with your personal identification document with your photo. At the venue, instructions on how to file your tax return are displayed and a booth will be set up where you can experience what it is like to file your tax using your smartphone.

Submitting a Completed Tax Return

We will set up a box where you can submit your completed tax return. Confirmation of content before submission or issuance of a reception stamp for your copy of the document will not be available. If necessary, please enclose a return envelope (with an address and postage stamp).

Regardless of your income type, if you have not yet prepared for your tax return, you can receive assistance at the following venue. The consultation service is available for a longer period than in previous years, but please note that the deadline



for filing and paying income tax is March 15th (Mon.)

Details Regarding Urayasu City Benefits

Granting Eating Establishments Temporary Assistance Benefits

For eating establishments whose businesses have been greatly affected by the prefecture's direction to shorten their business hours and self-restraint request made during the yearend and New Year holiday season, we will be granting temporary assistance benefits as an emergency measure.

Application Deadline

March 31 (Wed) (must be postmarked by this deadline)

Requirements to Receive Benefits

Businesses must meet all of the following criteria

Business approved as an "eating establishment business" under the Food Sanitation Act. **Note:** May not be applicable for benefits depending on business content.

► Eating establishment operating in Urayasu City that meets one of the following criteria as of January 1

- · Small and medium-sized business including sole proprietors under the Basic Act for Small and Medium-Sized Enterprises
- Sole proprietors
- Social welfare service corporation, incorporated nonprofit organization, general incorporated association and incorporated foundation, public interest incorporated association and incorporated foundation, or union, etc.

► Cooperate with requests specifically addressed to eating

establishments from the Governor of Chiba prefecture, which are based on the Act on Special Measures for Pandemics, Influenza and New Infectious Diseaseses (excludes eating establishments that are not subject to this request.)

▶ Business that is implementing infection prevention measures based on the infection prevention guideline determined by each industry association (must have obtained Urayasu City's infection prevention sticker)

Benefit Amount

¥100,000 per store (Limited to once per business location)

Application Procedure

By mail, send in a grant application form/invoice, application checklist (downloadable

from the Urayasu City website), and a copy of the eating establishment business permit to Urayasu City Hall Commerce Industry and Tourism Section, 279-8501

Temporary Special Fixed Benefits for Newborns

Urayasu City will grant benefits to households that received a special fixed benefit payment from the state as a measure in

connection with the novel coronavirus infection. If you are qualified to apply, please apply during the application period.

Qualified Recipients

- · A child who is a resident of Urayasu City at the time of application
- A child born between April 28 through December 31,
- A child born from a mother who is a registered Urayasu City resident as of April 27, 2020, and to the date of application

Benefit Amount

¥100,000 per child

Application Procedure

Please submit necessary documents directly or by mail by March 31 (Wed.) (must be postmarked by this date) to Maternal and Child Health Section

Required Documents

A copy of the applicant's official identification (driver's license, My Number Card, passport picture page, etc.). A copy of a document that can be used to confirm bank name, branch name, account type, account number, name of the account holder (bankbook, bank card, internet banking screen, etc.) **Note:** The procedure takes about 2 months, from the time of application to bank transfer of benefit amount

Water and Sewage Fees will be **Charged Together**

Water and sewage fees will be charged together by the Chiba Prefecture Public Enterprise Bureau as "Water and Sewage Fees" as of January 1, 2021. In accordance with this unification, if different billing names or payment methods were used to pay for water and sewage fees, we will automatically unify them under the name and payment method registered for water fees.

Note: In principle, no procedure is needed. For those with odd months billing, Prefectural Public Enterprise Bureau will bill water and sewage fees separately for the bill of January only. A Stroll with the Mayor

Avoid Misunderstandings by Familiarizing Ourselves with the "Marks"

To encourage the social involvement of persons with disabilities and aim to realize a "society of coexistence" which respects the personality and uniqueness of individuals, regardless of



whether they have a disability or not, the Basic Act for Persons with Disabilities has designated one week, from December 3rd to 9th, as the "Week for Persons with Disabilities."

Urayasu City has established "Regulations to Promote the Elimination of Disability Discrimination" and has been taking measures comprehensively, following the enforcement plan based on these regulations. However, cases have been reported where we have failed to show reasonable care due to some misunderstandings. Marks(pictograms) are designed to avoid such misunderstandings and help assist persons with disabilities to live comfortably, but research shows that the level of recognition for these marks varies among residents.

For example, the International Symbol of Access depicting a person in a wheelchair is widely recognized. Yet, the "help mark," which combines a heart shape with a plus sign to indicate that the person requires help, but his/her disability is not immediately apparent, falls short of recognition. Additionally, the "earmuffs" worn by individuals sensitive to sounds are mistaken for headphones and a "wheelchair for children" for strollers. I personally have seen people making heartless comments about them on a train and on a bus, due to this misunderstanding. The use of marks (pictograms) can be an effective way to eliminate these misunderstandings and help promote a better understanding of our society, to create an environment for persons with disabilities to become more proactive in our com-

We will raise further awareness of marks that have already been established so people can be more familiar with them. Also, for items that do not yet have a unified mark, such as "earmuffs" and "wheelchairs for children," we must design one that is easy to understand.

I warmly invite you to consider the Week for Persons with Disabilities as an opportunity to reflect again on how "we all live with different characteristics" in our society.
